

# DISC: WHAT'S IN IT FOR YOU?

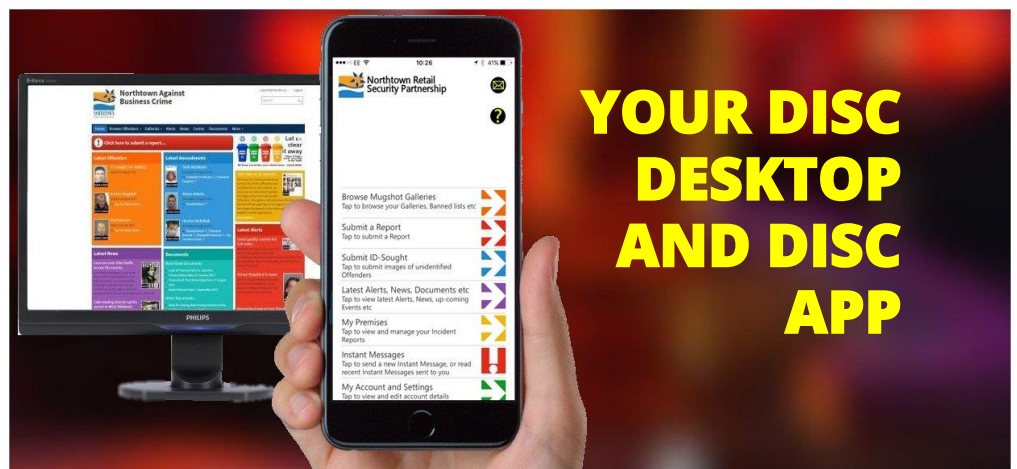
## DISC HELPS PROTECT YOUR BUSINESS FROM LOW-LEVEL CRIME AND ANTI-SOCIAL BEHAVIOUR

Disc is the secure online information-sharing system that helps protect businesses in more than 550 towns and city-centre across the UK. Now you can use it to protect your own business by reducing low-level business crime and anti-social behaviour in and around your premises.

### What is Disc?

Disc is the secure information-sharing system designed for local business crime reduction schemes such as Business Crime Reduction Partnerships, Business Improvement Districts, Shopwatches and Pubwatches.

Each Disc system comprises the Disc Desktop and the Disc App, which enable scheme-members to access useful information and to submit incident reports from their PCs, laptops, or smartphones.



Each Disc system is managed by an Administrator who looks after every aspect of the system from configuring it to suit your specific local requirements, adding members and managing the content within Disc, to processing incident reports submitted by Members through Disc and managing your local exclusion scheme or other programmes for reducing low-level business crime and ASB.

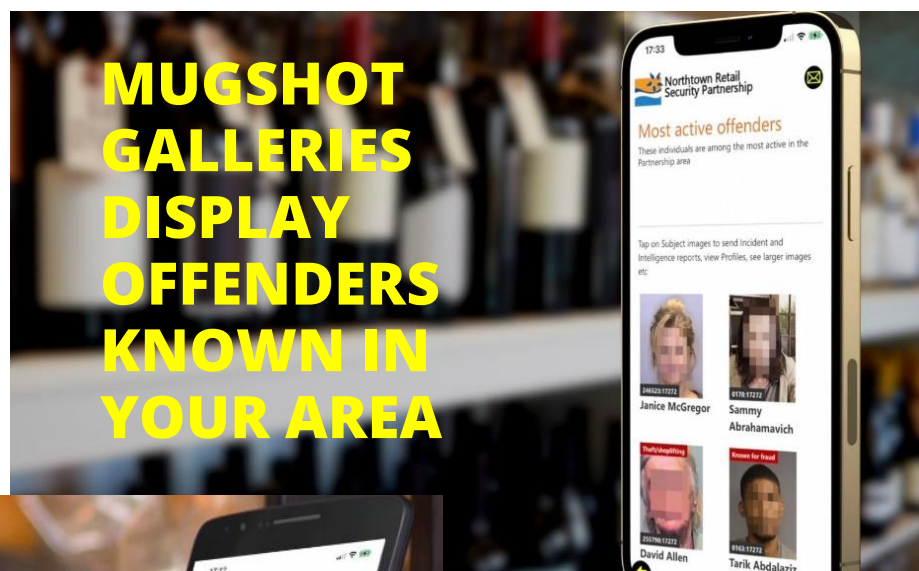
## What can I do with Disc?

You can access Disc on your PC or laptop via the Disc Desktop secure members-only website, or on your smartphone via the Disc App.

These give you easy access to useful information about local low-level crime and ASB that might impact your business. Information includes galleries of known offenders, as well as Alerts, news, information about up-coming events, useful documents and images of unidentified individuals – all accessible 24/7.

You'll also be able to use Disc to submit reports of incidents of low-level crime and ASB quickly and easily to your local Disc Administrator.

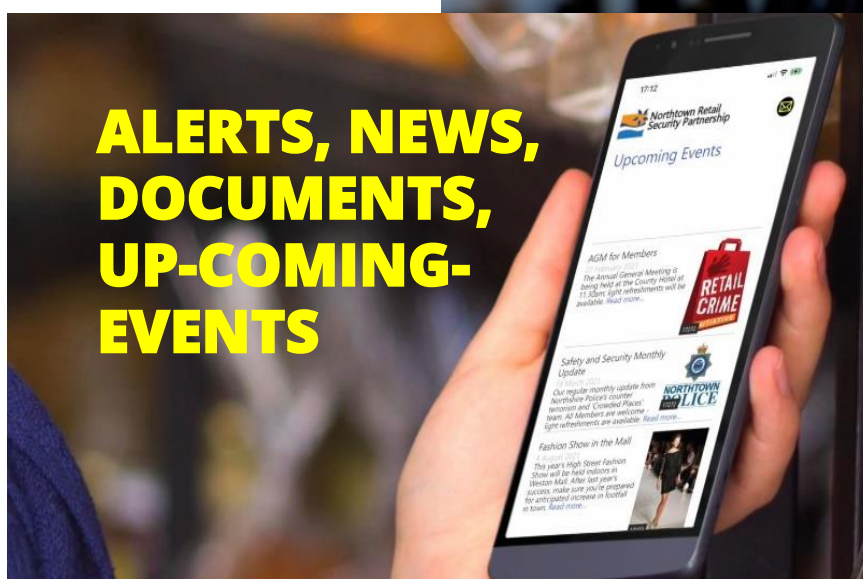

Administrator to manage 'Exclusion Schemes' and other initiatives on your behalf.

Schemes like these are proven to reduce the level of low-level business crime and ASB for participants.

Disc also includes an Instant Messaging system like WhatsApp that's safe to use without infringing important data protection law. So if you see something or someone you think other businesses around you should know about, you can use Disc to warn them in real-time.



And every week you'll receive your local Disc eNewsletter summarising everything that's been added to your Disc system in the previous seven days, so you're always up to date about low-level business crime and ASB that may threaten your business.

## How can I access Disc?

Disc is an 'invitation only' system – not everyone can participate. If your local Administrator believes you have a right to access the sensitive personal information that is in your Disc system, they'll send you a 'Welcome Email' which explains why you have been invited to join, and contains a click-on link for you to register.

Once registered, you'll be able to access your Disc system either by the Disc Desktop on your PC or Laptop, or on your smartphone via the Disc App. You'll need to download the App from the App Store (for iPhones and iPads) or Google Play Store (for Androids): just search for 'Littoralis Disc App.'
