OPEN FORUM

8. GRANTS ANNUAL BUDGET

- 8.1 The current annual allocation for the Grants Awards fund to cover the cost of Minor and Major grants is currently £12,000. This excludes the Green fund which currently stands at £7,588 and needs to remain as a ringfenced fund as agreed at Council on Monday 25 September 2023 (Minute 62 refers). The Grants Awards fund of £12,000 is agreed by the Finance Key Area Group, they are meeting on Wednesday 15 November 2023 and then full Council.
- 8.2 The Panel are asked to consider the grant allocation of £12,000 and consider the annual grant allocation and if they wish to request an increase in this amount via the Finance Key Area Group. The Panel are reminded that the Minor Grants phase 1 amounted to 10 applications for £9,434 of which £8,272 was allocated. Minor Phase 2 and Major funding applications are set out above to demonstrate the increased interest in the Council Grants funds.

8.3 **RECOMMENDATION**

The Panel are requested to consider the current funding allocation.

Risk Implications: The request will be considered by the Finance Key Area Group at their meeting on 15 November 2023 and then on to Council for final approval.
