The Chairman welcomed everyone to the meeting.

8. <u>OPEN FORUM</u>

There were representatives from The Friends of Woodlands Meed, The Guide Hall Committee, BH Flower Club, The Community Garden, BH Creative Community and Mid Sussex Radio present.

Representatives from Home-StartCHAMS, Air Ambulance Charity Kent Surrey Sussex and Burgess Hill Marching Youth were unable to attend but sent apologies.

The representative from The Community Garden spoke on their application, stating they had had interest from many organisations and charities who would like to be involved with the project and that they would like to engage with people of all ages. They stated the project was in an area of deprivation and they also informed the Panel that their unrestricted funds were very minimal and they had applied for other grants.

The representative from BH Creative Community informed the committee that membership had increased to 118 since the application had been made.

The representative from the Guide Hall Committee stated that the money within their account was built up over years of fundraising and hall hire fees. They added that the hall needed a new roof and that was at an estimated cost of £25,000, they hoped to also install solar panels when that work took place. They informed the Panel that they were

using a local firm for the work and the gates were being replaced like for like but were being re-sited for safety reasons.

A total of £4170 was allocated from the Major Grants Fund.

15. <u>COMPLETED GRANT EVALUATIONS</u>

The Panel were asked to note the information from past applications, which was provided via the evaluation forms at Appendix 3.

RECOMMENDATION The Panel noted the information in Appendix 3. The Panel felt in information was helpful and said it was great to see the success of the applicants' projects.

16. GRANTS ANNUAL BUDGET

The Panel were asked to consider the annual grant allocation of $\pounds 12,000$ and request an increase in this amount, via the Finance Key Area Group, if they felt it was not sufficient considering the number of recent applications.

The Panel discussed the need to support local organisations with grants. They suggested that the funds should be increased but ring fenced for different purposes. The Panel discussed that the increase may need to be taken from other areas and stated they did not wish the increased budget to be at the deficit of the Community Engagement budget, as the events benefit the wider community.

RECOMMENDATION The Panel requested an increased budget for 2024/25 to a total budget of £40,000, broken down into; Minor Grants fund £20,000 Major Grants fund £10,000 Green Grant fund £10,000

The Panel requested the above amounts be considered by the Finance Key Area Group at their budget meeting.

Meeting terminated at 19.52 hours.
